Our hearts are with the people of Ukraine and others who are suffering from Russia's invasion, including our team in Russia who share our concern and our fervent desire for peace. Motorsport Games is a global company diversified across 3 continents and 6 offices. Like many global companies, while our business is impacted by the war and the associated economic sanctions, we are executing our business continuity plan and adapting to developments in realtime. Our primary focus is protecting the safety of our people in the region, while at the same time implementing plans to mitigate the potential for disruptions to our development activities in the region, including reallocating work to other locations and suppliers in our network. We will continue to evaluate the situation and make decisions to help our business move forward, but above all to help our employees and their families in the region survive this crisis, which we hope comes to a swift and more peaceful end.
